7. YOU ARE UNDER APPREHENSION (IF MILITARY) / DETENTION (IF CIVILIAN) FOR THE OFFENSE OF DRIVING WHILE INTOXICATED. YOU WILL BE REQUESTED TO SUBMIT TO A BLOOD / BREATH SPECIMEN, FOR THE PURPOSE OF ANALYSIS, TO DETERMINE THE ALCOHOL CONCENTRATION OR THE PRESENCE OF A CONTROLLED SUBSTANCE OR DRUG IN YOUR BODY.

8. IF YOU REFUSE TO GIVE THE SPECIMEN, THAT REFUSAL MAY BE ADMISSIBLE IN A SUBSEQUENT PROSECUTION, AND IF CONVICTED, YOUR REFUSAL WILL RESULT IN YOUR STATE DRIVER'S LICENSE BEING SUSPENDED FOR UP TO ONE (1) YEAR, AND YOUR PRIVILEGE TO OPERATE A MOTOR VEHICLE ON FORT HOOD MAY BE REVOKED FOR UP TO ONE (1) YEAR.

9. IF, HOWEVER, YOU DO PROVIDE A SPECIMEN AND ARE CONVICTED IN A SUBSEQUENT PROSECUTION, YOUR STATE DRIVER'S LICENSE WILL BE SUSPENDED FOR UP TO NINETY (90) DAYS.

10. YOU DO NOT HAVE THE RIGHT TO AN ATTORNEY PRESENT BEFORE STATING WHETHER YOU WILL OR WILL NOT SUBMIT TO THE TEST, NOR DO YOU HAVE THE RIGHT TO HAVE AN ATTORNEY PRESENT WITH YOU DURING THE ADMINISTRATION OF THE TEST.

11. I CERTIFY THAT I HAVE ORALLY INFORMED YOU OF THE CONSEQUENCES OF A REFUSAL OR PROVIDING A SPECIMEN WITH AN ALCOHOL CONCENTRATION OF A LEVEL SPECIFIED IN SECTION 49.01, TEXAS PENAL CODE. I NOW REQUEST THAT YOU SUBMIT A BLOOD / BREATH SPECIMEN, FOR THE PURPOSE OF ANALYSIS, TO DETERMINE THE ALCOHOL CONCENTRATION OR THE PRESENCE OF A CONTROLLED SUBSTANCE OR DRUG IN YOUR BODY.
