

**FORT HOOD DEPOSIT WAIVER PROGRAM**

(FH REG 210-50)

**APPLICATION FOR A WAIVER**

1. Privacy Act Statement - Authority: 5 USC 552a.

I desire to voluntarily participate in the Fort Hood Deposit Waiver Program.

I understand that I am not required to release my forwarding address and other personal financial information; however, refusal to do so will result in denial of participation in this program. I waive my rights under the Privacy Act and authorize any government agency or agent to release my home forwarding address to the Utility or Landlord named herein for the purpose of collecting unpaid debt or damages to a dwelling caused by me or a member of my family, or guest while I was a participant in the program. I also voluntarily consent to give my commander and Command Financial Specialist personal financial and indebtedness information for the purpose of budget counseling. I authorize any of the companies below for which I have received a deposit waiver to exchange information with the Deposit Waiver Office concerning my account. If I have an unresolved dispute with my landlord concerning rent or damage charges, I voluntarily consent to submit my dispute to the Housing Arbitration Officer and abide by his decision. **I understand that if I use the RENTAL DEPOSIT WAIVER I will not be assigned government housing until the Waiver form is returned to housing.**

4. SOLDIER WHO DISCONNECT SERVICES, OUTPROCESS, OR RELOCATE WITHIN THE AREA (TO INCLUDE MOVING ON-POST) MUST PAY FINAL BILLS AND RETURN THIS WAIVER OR SIGNED RELEASE FROM THE UTILITY/LANDLORD TO THE DEPOSIT WAIVER OFFICE BUILDING 108.
