TO: ALL DOD PERSONNEL

The CID has brought to our attention their involvement in several cases where attempts to defraud the government in the DO - IT - YOUR SELF movement of household goods were disclosed. INSTANCES OF FRAUD HAVE BEEN DISCLOSED AND SEVERE PENALTIES HAVE BEEN LEVIED AGAINST THOSE FOUND GUILTY.

UNAUTHORIZED ITEMS

1. PRIVATELY OWNED VEHICLES/RECREATIONAL VEHICLES (RV'S)
2. FLAMMABLE, COMBUSTIBLES, OR EXPLOSIVE
3. AIRPLANES, AIRPLANE PARTS AND ENGINES, CAMPER TRAILERS & FARM EQUIPMENT.
4. MAJOR MOTOR VEHICLE ASSEMBLIES, INCLUDING ENGINES, TRANSMISSIONS, DIFFERENTIALS, DRIVESHAFTS, ETC....
5. BUILDING MATERIALS SUCH AS LUMBER, CONCRETE BLOCKS, BRICKS, CEMENT, FIREWOOD, ETC...
6. QUANTITIES OF ANY ITEM INTENDED FOR USE IN A COMMERCIAL ENTERPRISE
7. AMMUNITION
8. HOUSEPLANTS ARE AUTHORIZED. HOWEVER, NO CLAIM FOR DAMAGE TO OR CAUSED BY HOUSEPLANT IS AUTHORIZED. IT IS YOUR RESPONSIBILITY TO KNOW STATE REGULATIONS REGARDING TRANSPORT OF PLANTS INTO OR THROUGH STATES.

I UNDERSTAND THAT THE MOVE APPLIED FOR IS TO BE MADE AFTER HAVING BEEN COUNSELED BY TRANSPORTATION IN MY COUNSELING APPOINTMENT.

I UNDERSTAND IF THERE ARE ANY QUESTIONS OF ATTEMPTED FRAUD ON THE WEIGHT MOVED OR DESTINATION MOVED TO, IT WILL BE TURNED OVER TO THE CID FOR INVESTIGATION.
